Technical Performance Comparison AEROFLEX EPDM™ v NBR/PVC Closed-Cell Elastomeric Insulation

The intent of this technical bulletin is to illustrate, without bias, the technical performance characteristics of EPDM and NBR/PVC [Nitrile Butadiene Rubber/PVC] closed-cell elastomeric insulation for building mechanical systems: piping, ducts, and equipment. Data was obtained from publicly available technical data sheets of 2 leading U.S. manufacturers as of the date of this publication.

<u>Note</u>: NBR/PVC manufacturer formulations: NBR/PVC through 1" thick; EPDM @ 1-1/2" and 2" thick.
